Sir,

This is to bring to your kind notice that there are 3 (three) rice mills of Jalpaiguri District viz.

1. Khrishna Bhog Food Products
2. North East Agro Product
3. Evergreen Rice Mill Pvt. Ltd.

which had experienced difficulties in uploading their Bank Guarantees within 30.10.2024. The issue was eventually solved with the help of the Reforms Cell and DDPS Directorate by which time, the it was the middle of November, 2024.

However, these rice mills have

- a) Completed their RCMR delivery of KMS 2023-24 21.09.2024.
- b) Signed BA1 and BA2 before 30.10.24
- c) Received paddy greater than 10% of their total milling capacity in KMS 2023-24

Therefore, it is requested that the category of these mills may kindly be upgraded to A1 and corresponding paddy holding limit increased as per A1 category, in the interest of paddy procurement in Jalpaiguri district.
